- Lastly, as many have noticed, interest rates have risen over the past year both on loans as well as investments. To put this in a ministry context, this interest would fund approximately 400 VBS programs, or send over 1,100 students to Ponderosa Camp for free! Colorado Baptist Disaster Relief Dennis Belz, State Director

Since our CBGC Annual Meeting last October, Colorado Baptist Disaster Relief (CBDR) has been keeping busy with deployments in state and out of state along with trainings and upkeep of our vehicles and equipment.

Hurricane lan- Florida Deployment in November, 2022. CBDR sent a team of 15 volunteers to the Daytona Beach, FL area to assist with mud-out and cleanup efforts from the hurricane. We were able to complete 8 major clean up jobs. The team was able to present Bibles to each of the homeowners along with opportunities to share Christ with them. Due to an outbreak of Covid, we did not deploy our second team.

"PETE" (National Partnership for Environmental Technology Education). This is one of our new CBDR partners that supports our ministry. In January, I led 3 conferences and hands-on sessions of CBDR Mud-Out procedures along with OSHA Safety. Most of the participants are from colleges around the country. This year, I was able to invite 3 of our CBDR leaders to attend the week long trainings offered. In April, I led week long safety training with "PETE" in Puerto Rico.

My wife and I attended the **National SBDR Round Table** in Jacksonville, FL on January 24 -27. This is where all our SBDR National and State Disaster Relief Directors come together to plan and conduct needed business. Many things are changing these days and we need to keep abreast of these changes.

NORAD- Peterson Air Force Base – I was invited to speak about CBDR to over 75 military chaplains and officers from around the country during their Religious Affairs Workshop.

CEMA Conference (Colorado Emergency Management Association) is an annual meeting that I attend to represent CBDR. This group is made up of all the Emergency Managers in the state of Colorado. Each year, I set up a display representing what CBDR is about and received opportunities to speak with the Emergency Managers and other State Officials.

CSEPP (Chemical Spill Emergency Preparedness Program – we were invited by the Pueblo Sheriff's Office to participate in this event where our CBDR Feeding team prepared and served 100 meals to the participants.

CBDR Annual Leadership Retreat was hosted by Applewood Baptist Church, Wheat Ridge.

CBDR trainings held in 2023:

- CBDR Training hosted by Bookcliff Baptist Church, Grand Junction
- CBDR Training hosted by Steel City Fellowship, Pueblo
- Chainsaw Training in Fairplay followed by doing and hands-on fire mitigation job
- First Aid/Stop the Bleed training with the American Heart Association hosted by Community of Grace
- Participated with Adams County Community Safety Fair "Touch A Tuck" to share about CBDR

New CBDR Shower Unit has arrived and in service for deployments.

Highlands Ranch Tornado - On June 22nd an EF-1 tornado ripped through the area of Highlands Ranch in Jefferson County. We immediately began to get a team together to deploy to the location to begin cleanup efforts. Due to all the heavy rains we had been receiving on the Front Range, flooding was one issue that made our deployment difficult as the location that stores most of our CBDR Vehicles is located at Creekside Community Church in Elizabeth, CO. The main road and driveway to the church was completely washed out! Once permission was given by the neighbor to allow us to drive through his field to get our needed units, the team could finally begin deployment.

- Find an enclosed building/Pole Barn or location to park our CBDR Vehicles near the I-25 corridor near Boulder or Longmont.
- Have 4 regional areas to host CBDR Trainings
- Conduct training for our WYDR Partnership Volunteers

Ponderosa Retreat & Conference Center Andrew Clark, Executive Director, Ponderosa

2023 has been an amazing year at Ponderosa. It has been a privilege to watch the Lord work in many ways this year. His blessing on Ponderosa has become more and more clear as the year goes on. Our winter and spring seasons have grown in the number of churches coming for retreats and our "slower" season is not so "slow" anymore. Our snow tubing hill is becoming more and more popular with weekend retreats and even church-wide snow tubing day trips. Additionally, this January, we changed our entire operating software to a new, more modern system called Campwise. This has been a big project, but well worth it, bringing our reservations, summer camp registrations, and staff reports up to modern times.

The summer season has been a blur of activity and a successful season of ministry. This was the first summer for our new Program Director, Emily Ray, and she has done a wonderful job as a new part of our team. In addition to our normal program camps, Peak (kids) and Summit (youth), Emily has helped to start a new version of Summit called "Summit Serve" which is more missions focused. We had great numbers of attendees at all these camps as well as the rest of the summer season. The sound of the bell ringing was a continuous encouragement to our team and all those involved as we celebrate what God is doing.

At the time of this writing, it is currently still outdoor education season. During the months of August and September we host a large number of school programs for outdoor education. These programs are heavy on the activity side, utilizing all that the recreation department has to offer. This season extends our summer business until the fall, filling the camp during the weekdays, providing excellent activities for the schools, increasing our partnership with the community, and maximizing our incomes. Our fall retreat season has grown in popularity as well, and our weekends are currently 95% booked until the end of November.

It is a privilege to report to you what the Lord has done so far since January of this year:

- 194 Salvation decisions/Professions of Faith
- 54 Rededications to Christ
- 57 Calls to ministry

We are currently praying for financial partners to help us build a security gate system that will help ensure that only our registered guests can have vehicle access to the property, similar to a gated community. Lord willing, starting next summer, groups will receive a gate code with their reservation that will give them entry to the new gate. This will provide an added level of security for our kids while they are at camp. Please pray about partnering with Ponderosa on these improvement projects and others. Ponderosa Program Camps 2023 Emily Ray, Camp Programming Director

Ponderosa served 965 students and church leaders from all corners of Colorado as well as three other states during our 2023 program camps. We had the great privilege of witnessing 161 young people come to know Jesus Christ as Savior and Lord for the first time during our Summit Youth Camp and Peak Kids Camp. It was great to see returning churches and new groups join us for a time of retreat, worship, and time in the Word. It was an honor to share and celebrate with churches who had students come to Christ, rededicate their lives or answer the call to ministry.

We kicked off a brand-new camp called Summit Serve this summer. The students and leaders who attended Summit Serve were able to serve different communities in Colorado Springs, Fountain, and Ponderosa's campground. They participated in a community prayer walk, a free soccer camp, grounds work and handing out care bags to the homeless. It was wonderful to see our attending churches connect with the other youth groups and serve alongside one another. My prayer is to have the opportunity to serve even more communities through this new missions-minded camp in years to come.

As we plan for our 2024 camps, we hope to continue to serve churches across the state and country. We are excited to start back our winter retreats for students, Summit Winter Camp and Benchmark as well as have our five sessions of summer camp in 2024. We strive to provide a place for churches of all sizes to grow together and connect with each other in an environment that is filled with the Holy Spirit.





Colorado WMU/Missions Discipleship Claudean Boatman, CO WMU Executive Director

Prayer for Colorado churches, church plants, pastors, and planters has been our primary focus during the 2022-2023 church year. Nearly every month, women have gathered virtually to pray for those leading our churches and church plants. In addition, Colorado WMU joined Tennessee WMU members as they prayer walked in the Front Range. Tennessee WMU has been faithful to pray for our church planters during a monthly call with planters and to lead in prayer walking in specific areas new church planters are working.

Missions Discipleship is another major focus for us. Missions Discipleship is simply helping believers

- understand the biblical basis for missions
- learn about missions work (both internationally and in North America)
- · pray for missions work and workers
- give to support missions
- participate in missions efforts

To that end, we have created a web site to help Colorado Baptists find resources in each of these areas. COBMD.org has links to missions education resources for every age group, ways to engage the local church (not just women) in praying and giving, as well as potential ways to be on mission locally, in the United States, and internationally.

One section of the site will provide information on a variety of compassion ministries offered through Woman's Missionary, Send Relief, and the National Literacy Missions Partnership. Such ministries provide open doors to share the Gospel while meeting felt needs of those to whom a church is ministering.

Colorado WMU's Annual Meeting and Missions Celebration will be Saturday, March 23, 2024, at Heart of Junction Church, Grand Junction. Women from all over the state are invited to hear from missionaries, discover ways to help their churches be involved in missions, and pray for missions. We will also conduct WMU business that day.

We love Missionary Kids! Colorado WMU is working with Tennessee WMU to raise funds and staff the 2027 MK Re-entry Retreat. Each summer state WMU organizations help the IMB provide a retreat for missionary kids transitioning to life in the United States before they begin college classes. They attend Bible studies, have meaningful spiritual discussions with IMB staff, and take part in fun activities. The students bond with each other and leave the retreat with practical skills as they adjust to their new surroundings. The retreats are funded by the hosting state WMU. We have volunteered to help Tennessee WMU with the 2027 Re-Entry Retreat. We will start fundraising and asking for volunteers soon.





Colorado Literacy Missions Ministries Claudean Boatman, Literacy Missions Coordinator

Literacy Missions Ministries include three areas of ministry:

- Adult Reading and Writing: teaching adults to read better
- English as a Second Language: teaching non-English speakers or those with limited English learn to converse in English
- Tutoring Children and Youth: helping school-aged children do better in school

Each ministry has a specific equipping workshop that can be conducted in person or in a hybrid format (online for most of the content and in person for the demonstrable skills). Equipping volunteers is important for these ministries to be effective in meeting the needs of the students. The workshop includes these topics:

- Writing a short testimony to be used with students
- Using the Bible during classes or tutoring sessions
- How to teach English (ESL)
- How to teach an adult to read (Adult Reading and Writing and Tutoring Children and Youth)
- Understanding your students
- Planning lessons
- Organizing a ministry

Workshops are geared to volunteers, not professional teachers, who want to be effective in helping their students and want to share their faith with students and their families.

Currently, we do not have a few ESL ministries. We are looking for churches wanting to reach one of the three target groups to begin ministries.

We also need interested volunteers who are willing to help promote the ministries and become workshop leaders who can train local church volunteers to share their faith through these ministries.

The literacy missions basic workshops are conducted through the National Literacy Missions Partnership (NLMP) and Send Relief. The materials were developed by the North American Mission Board. The Partnership is tasked with keeping the materials current and equipping basic workshop leaders.





Arkansas Valley Baptist Association Nate Templin, Regional Director

This year has been a great chance to really get to know the AVBA churches and leaders. I have appreciated the opportunity to dive in and serve the various churches as needs have arisen. It has also been great to hear the hearts of the leaders and how they are making much of Christ in their area.

Here are a few of the ways I have been serving the churches and leaders of the association:

Assisting Cheraw Baptist Chapel as they became pastorless:

- Assisting the prior pastor and family through the transition.
- Working with the church body in processing the situation.
- Working with Brandon Mills from FSBC La Junta to develop a strategic partnership and in finding a leader to help replant the church.

Assisting the AVBA with a church building in Rocky Ford:

- Working with insurance and a local roofing company to repair the roof of the Rocky Ford Church building after a hailstorm.
- Working with a local realtor to secure the sale the Rocky Ford building.

Partnering with Scott Johnson of Calvary La Junta to take Dennis McDaniel through SEND Church Planter Training.

Managing AVBA financial circumstances:

- Supporting Susie Brookshire, our new treasurer, and the HUB to recover and secure \$30,000 worth of electronically stolen funds.
- Working with Susie to assess and create safer methods and processes for funds.

Supporting and working with 5 pastorless churches through various levels of crisis.

Assisting Jack Fuller, the new pastor of Hands of God Church, as he worked through pastoring in two cities and navigated food distribution.

Assessing the financial situation and current processes to create procedural changes for the purpose of better serving the churches.

Acquiring up to date church and leadership information while developing clearer communication processes between leaders, the association and churches.

We pray that this next year will be a year of building up the churches and extending the kingdom in Southeastern Colorado.





Continental Divide Association Michael McVey, Regional Director

ISOLATION: In my first year of ministry serving as Regional Director I have learned that several pastors in the CDA are remotely located and struggle with being isolated, often an hour away from the nearest fellowship. The CDA consists of 16,197 square miles, 25 Association churches one church for every 675 squares miles. Loneliness is real!

RELATIONSHIP: I have spent the first nine months seeking to build relationships with pastors of the association. The creation of the Regional Director role has been huge in coming along side pastors and churches simply being a presence and friend.

TRANSITION: Assisted Trinity BC in Gunnison call their new pastor. It was a unique transition in appointing one of their existing elders to serve as Lead Pastor. It has been an incredible transition.

RENEWAL: The year has been taking time to renew connections with association churches that had disconnected for various reasons. We are seeing pastors recognize and begin to see the huge need of someone to come alongside of them.

REPLANT:

- Assisting Mountain Crest BC in Leadville through the replant process working alongside Agape Outpost as the lead church in this process
- Calvary Church Monte Vista is actively in the replant process through Calvary Family of Churches.

LEADERSHIP: We have been able to meet with the Hispanic churches once a month to help them equip and encourage them in their leadership. We are working to develop a training institute to disciple and teach Scripture.

ADVISE: We have been able to assist and encourage the pulpit search team for Creede Baptist in Creede in their search for their next pastor.

HEALTH: The primary goal for this year is to assist pastors and churches to ensure that they are operating from a healthy emotional, spiritual, physical, and mental framework; to encourage them to function by the placing spiritual process before product. In others "being before doing." A healthy leader leads to a healthy congregation.





Grand Valley Baptist AssociationJeff Bachman, Regional Director

It has been an amazing nine months as the regional Director of the Grand Valley Baptist Association (GVBA). I have been amazed at how well we have been able to partner as CBGC and GVBA. Below is a list that describes the ministries and opportunities that have happened through this partnership.

Assisting several churches in the HCBA, with Pulpit Supply

 Helping 4 churches (Yampa Baptist Church, Emanuel Baptist Meeker, Mid Valley Glenwood Springs, and Trinity Edwards) as they search for a new pastor or discover what their next steps are for a pastor or replant.

Connecting with the HCBA leadership

- Helping to define roles and the purpose of the association moving forward.
- Connecting with each pastor in the HCBA to build relationship so that there can be more
 cooperation within the association, allowing each pastor to know that we are in this together and
 that they are not alone.
- Helping churches in the HCBA with Grant Requests and Block Party Trailer scheduling for outreach and evangelism events across the association.

Network with the other 6 Regional Directors across the state, Rocky Mountain Foundation and CBGC Staff

- This allows me to collaborate on best practices and how to help the churches in the HCBA moving forward.
- Introduced our churches to the new president of the RMF, Matt Trombley, so that connections could be made for future partnerships with the foundation.

It has been an honor to work and serve with the other Regional Directors and the other CBGC staff as we discuss the future vision of the CBGC and its partnership across the state with all our churches and associations.





Longs Peak Baptist Association John Howeth, Regional Director

I am reminded of an axiom for churches I realized years ago: what matters most is not how long a church exists but what a church does while the church exists. Jesus Christ commissioned his church to be about the Great Commission not about trying to stay in existence for a long time.

The LPBA's mission statement says we exist to help our churches accomplish their God-given vision to carry out the Great Commission. We are seeking to care for the churches in our region.

As your Regional Director in the LPBA, I have sought to lead in such a way that benefits both our local association of churches and our state convention. Here's a recap of ways I have been able to assist our churches and associational work:

- → Guiding Living Stone Church in Pierce as they go through a revitalizing process by:
 - Helping them come under the care and oversight of Cornerstone Baptist, Windsor.
 - Connecting a new Interim Pastor, Mike Smith with Tree Cooper, Pastor of Cornerstone.
 - Assisting them in the formation of a Transition Team that consist with 4 people from Cornerstone and 3 people from Living Stone, plus the Interim Pastor and myself.
 - Helping them update their Constitution and write a Policies & Procedures Manual.
- → Guiding/consulting with the Pastor Search Committee at Orchards Community Church in Erie to be trained and resourced in their Pastor search process.
- → Facilitating or guiding four church leadership teams through the "Leading from Your Strengths" process by helping them do the individual assessments and then I and/or Duane Arledge, our Next Steps team lead, help them interpret and understand their results collectively as a team.
- → Helping two pastors meet, Ed Stepp and Doug Hixson, as Nelson Road Baptist Church became a legacy church for Connection Church in Longmont.
- → Working with our trustees and associational leadership to absorb the assets of Compass Church of Loveland/Timnath so that their equipment could be shared with other churches.
- → Working with our trustees and Calvary Family of Churches to assume and be good stewards of the assets and property of a former church in Lyons.
- → Facilitating and meeting with Pastor Noah Adams and staff at City Park Church in Ft Collins in redefining their mission, values, strategy, and outcomes for making disciples.
- → Helping Andy Duke, our Church Outreach/Planting team lead and Nancy Mann, LPBA's Ministry Assistant get our fleet of three outreach trailers ready to be used by our churches for outreaches this year.
- → Assisting and facilitating in the Church Planter/Replant HUB gathering that the LPBA funds and organizes to help encourage, support, and pray for planters and replanters. This network is the longest running network in the state and may expand this coming year.



In addition, there is the ongoing practice of participating and praying alongside Tree Cooper, our Leader Care Development team lead, in praying with and for the pastors of our association as well as checking-in personally with our pastors/staff by phone or in person.





Mesa Verde Baptist AssociationDavid Smith, Regional Director

Working with two associations can at times become disorienting. I am not sure whether I am coming or going. This has been one of the greatest challenges over the last year as I have learned to serve in this role. As a pastor, there are things that come up from time to time that are out of the ordinary. You deal with them, and then life and ministry get back to normal in a way. It can have some predictability to it.

Over the last year, I have learned that in this position you never know what to expect. Even when you think you know what you are walking into, you don't. From one meeting to the next, you must be able to switch gears and set your mind on what is coming. For someone who is a processor this can be a real struggle. I want to process everything that I have just encountered. I want to let it sink in and think through it all. This is a possibility when you have a three-hour drive home. It cannot happen when in ten minutes your mind needs to be focused on the next church and what is happening there. God is working that out in me.

This last year in the MVBA has been a learning curve as well. Unlike the UBA where I knew and had some relationship with all the pastors I had to meet, I now must work to build relationship with every pastor. I wish I could say I have been successful at this. If I am honest, I have failed at times. I have had good moments, and I have had bad ones. I have built relationships with some of the pastors and others I have neglected. I know that God is still growing me and over the next year I will be better.

I am very excited about the future of the MVBA. Currently we are working on restructuring leadership, writing a new constitution, new church plant support strategy and creating a church grant policy.

The pastors in the MVBA are focused on building the Kingdom and collaborating to do this. We have two churches who are partnering with pastorless churches to help them through their transitions and multiple churches who are standing ready to help other churches however possible.

The MVBA is currently exploring a partnership with Shady Crest Baptist Church in Texas. In September, some of the churches took part in Lifeway's Sunday School Essentials Training.

Over the next year I would like to start a pastor's prayer and fellowship time and hold a Great Commission Summit, an opportunity for our pastors to collaborate on ways to overcome what is hindering them from reaching their communities.

Tracy and I have worked hard to build relationships in the MVBA and over the next year we will continue to do so.

Mile High Baptist Association Matt Olson, Regional Director

I am just getting started in my new role as Regional Director for the Mile High Baptist Association and could not be more excited about the opportunities we have ahead! Having served as a Coaching Champion for the Send Network and working with a number of pastors and churches in the metro area over the years has given me a bit of a head start but there is still so much I need to learn about our city, churches, and pastors.

From the first day I have been reaching out to pastors and just listening, asking questions, and then listening some more. This is how I am spending the majority of my time right now. Those meetings and conversations have been eye-opening and incredibly encouraging.

I feel the most important task right now is building relationships. It is my plan to connect with every pastor in the Mile High Baptist Association before the end of the year. I may not reach that goal, but I am still going to shoot for it. One of the ways I hope to do this is by asking key pastors to gather those they know and host a "meet and greet".

Pikes Peak Baptist AssociationBill Lighty, Regional Director

Collaboration is the New Normal in the Pikes Peak Baptist Association for 2023-2024!

In the Pikes Peak Baptist Association we have seen over 20 churches and church plants collaborate for the Gospel and Kingdom Impact in the Pikes Peak Region and beyond.

Here are a few examples:

- This summer Souls Church in Manitou Springs collaborated with four other local churches to renovate the teacher's lounge for Manitou Springs Elementary School. This would have been impossible for one church to accomplish. The goal of the project, beyond serving the local school system, was to demonstrate to the school administration that local churches are partners and not adversaries.
- Cross Fellowship Palmer Park extended to International Christian Fellowship (ICF) the use of their facility when ICF had to vacate from their rental facility because of a sewage backup that took over 2 months to restore.
- Monument Hill Church, Garden Ranch Baptist, Fellowship of the Rockies Colorado Springs, and Fountain Valley Baptist in Fountain reached out to the Howard Church, Colorado, and restored the facility by investing time, labor, and money, to prepare the church and parsonage for a new church planter, who we hope will be on the field before the end of 2023. This property and building had been vacant for over 2 years.
- Heart of the Springs Church has collaborated with Story Church in an underserved area of Colorado Springs as the Story Church reached out to multiple street gangs and served as a sanctuary for the leaders to have significant dialogue. Their prayer is to remove as many bullets off the street as possible.
- Cross Creek Church and Fountain Valley Baptist Church, both in Fountain, have collaborated with a new Filipino church plant in Fountain. One church is providing the administrative and support services and the other church is providing a facility for the church plant to utilize.
- The Worship Leader Cohort, led by Rob Latham at The River Church in Monument, has trained new worship leaders for two of our local churches: Calvary Baptist in Colorado Springs and Creekside Church in Elizabeth.
- Fellowship of the Rockies, Cross Fellowship, and Heart of the Springs, all of Colorado Springs, have collaborated with Open Bible Baptist by serving and financially supporting the Medical Clinic and TLC Pharmacy, which serves the underserved in our community.
- Monument Hill Church in Monument has collaborated with a new church plant, True North Fellowship, also in Monument, and is allowing the church plant to meet in their facility.



 Vista Grande Baptist Church in Colorado Springs collaborated with our new partners from the North Canadian Baptist Association south of Tulsa, OK to utilize their facility to enable this mission team to serve Open Bible Baptist, Mountain View Bible Church, and the Eagle's Nest BSU house.

The Pikes Peak Baptist Association of Churches comes alongside each of these churches to assist, network, and resource the churches to fulfill their unique God-given mission. Collaboration is our new normal.





Royal Gorge Baptist Association Nate Templin, Regional Director

In the Royal Gorge Baptist Association, we spent much of the last year in transitions. David and Kathy Britton retired at the beginning of the year and there were many adjustments that had to be made as they were critical to the day to day. Our ministry assistant, Laura McKinney, also moved. Through all the transitions, we were still able to create healthy procedures, and our churches are working together constantly. Here are a few of the ways I have been serving the churches and leaders of the association:

Navigating the use and replacement of the Event Trailer after it was stolen:

- We had to file an insurance claim and rebuild/replace the trailer and all the contents.
- We facilitated the use over the last year by many of our churches.

Facilitated financial and facilities support for a church plant in Southern Pueblo:

 Assisted church planter Scott Godinez through creating an Advisory team and facilitation the use of the Lake Ave building. He will Launch LACC in Fall 2023.

Assisting churches through A13, our leadership development apprenticeship.

Our Acts 13 Apprenticeship was at an all-time high in attendance. We saw 45 individuals in our
two-year process who are being equipped as missional disciple makers. We have begun to see
several entering leadership positions around Southern Colorado. We have also multiplied the
process to various other states.

Assisting churches that have become pastor-less as they navigate their next steps.

Facilitating Vision Next Steps with Ken Wood and The Avenue Church.

Overseeing the remediation, removal and restoring of our Associational house which had a pipe burst during the negative temps in December and saw lots of damage. We worked long hours with the insurance and the remediation company.

Other events run by our Association:

- Lonnie Hartke and David Britton led our Annual Beast Feast (wild game dinner) and it was a huge success. Men from local churches brought lost friends who heard the gospel from a professional hunting guide. We saw over 200 men in attendance.
- Kayla Holderman and Stephanie Scott lead the RGBA VBS annual training and saw many come from around the state to be equipped and have fun.
- We held a Christmas dinner for our pastors and families. It was a full house and we had lots of laughs. It was a great time together encouraging one another.

One of the most exciting things this last year has been starting to implement our new mission and strategies, to develop lead disciple makers for every community in Southern Colorado. We hope to continue this momentum over the next year.





Uncompange Baptist AssociationDavid Smith, Regional Director

The last year as Regional Director in the Uncompahgre Baptist Association has brought much change. Change in my personal life & change in the ministry. Even as an association we are seeing change. We have changed the way we partner with Church Plants, we have changed the way we partner through grants, and we have changed our vision for the future of the UBA.

One of the greatest changes that we have seen in the UBA is our change in willingness to collaborate for greater impact. One example of this collaboration came to fruition on September 11th with the opening of "The Pastoral Institute of the Western Slope". This training institute was a collaboration of 5 UBA churches, the UBA & the CBGC. In addition to the Pastoral Institute the UBA is exploring the possibility of partnering with Shady Crest Baptist Church in Texas. We just held our first Great Commission Summit where we discovered some things hindering our churches from reaching their communities and came up with some ways to overcome.

In September Lifeway Christian Resources came and led a Sunday School Essentials Training.

Over the last year, Tracy and I have worked hard to serve our pastors in the UBA and we will continue to do so into the next year.

Church Planting Report Frank Cornelius, Church Planting Leader

We thank Colorado Baptists churches for being great partners in planting new churches. Many of our churches are sending or supporting churches for church plants. Without your partnership, planting new churches would be even more difficult. With your partnership, we have more people praying, participating in mission, and providing resources for the harvest.

Currently, we have 53 planters on the field with several more to be added by year's end. That is 53 communities hearing the message of salvation in Christ. We expect to count 15 new churches in 2023. While we celebrate new churches being birthed, we also realize "church planting isn't about starting one new church, but it's about expanding the Kingdom" (Vance Pitman). That is why we place a great emphasis on sharing the Gospel, discipling new believers, and leadership development. We want to see new churches birth new churches that birth new churches.

We have seen some great examples this year of churches planting churches. Overland Church Ft Collins sent a planter and team to Durango. Crossroads Church Pagosa Springs and Connect Church Canon City are teaming up to plant a church in Howard. In CBGC's early days, this was the pattern for planting new churches. A church (or two) would see a community in need of the Gospel and respond by investing what was needed to start a church there.

We are also seeing great examples of churches putting processes in place to train and send out planters and teams to start new churches. Several churches in the Montrose area are working together to train and send leaders. Calvary churches continue to train and send. Acts 13 in Pueblo is a training hub for churches in the southern Colorado area. These types of development environments will allow us to deploy indigenous leaders to start churches across our state.

Deuteronomy 3:2, 4-5 says, "But the LORD said to me, 'Do not fear him, for I have given him and all his people and his land into your hand'... And we took all his cities at that time--there was not a city that we did not take from them--sixty cities, the whole region of Argob, the kingdom of Og in Bashan. All these were cities fortified with high walls, gates, and bars, besides very many unwalled villages." Many cities in Colorado are fortified with walls and gates erected by our enemy, Satan. These walls serve to keep people blinded and enslaved by the lies of the enemy. Most of our planters serve in cities, towns and communities that are fortified by Satan, enslaving people to addictions, self-sufficiency, and works-based mentalities. Please join us in praying that Gospel forces would overrun and take back these cities for the Kingdom of God.







Colorado Christian Challenge Derek Gregory and Kent Slack, Co-Directors - Collegiate Ministries

Christian Challenge is how Baptist Collegiate Ministries is known in Colorado and is active on 12 campuses across Colorado. Over the last year through these ministries,

321 students were actively involved
4381 students were engaged through programs
12 students made professions of faith
155 were involved in discipleship
15 were called to ministry

(51,595 nation-wide) (40,1388 nation-wide) (2,748 nation-wide) (21,709 nation-wide) (1,722 nation-wide)

We are extremely grateful to be partnered with Colorado Baptist Churches and the CBGC in the advancement of the gospel and the fulfillment of the Great Commission. All 22 full-time, self-supported staff across the state are praying and laboring towards these goals and to see the numbers above increase. Please be praying for us as reaching students on campuses is not getting easier, but then that's part of the Christian challenge - called to obedience, not ease. Also pray with us as we desire to place directors on campuses in Denver, Pueblo, and Golden this year.

Here is one story from last year:

"My name is Maya. Growing up, my family went to church on holidays, but I did not pay much attention, nor did I know the meaning of any of it. My childhood was marked by depression. Most of the time my whole life just felt gray. I struggled with depression, disassociation, and an awful lasting feeling of hopelessness for 11 years. I had a constant feeling of being lost, always looking for something that would give me a sense of fulfillment or satisfaction.

My sophomore year I found out about Challenge. My roommate invited me to an event that she had heard about where there was free food. There were some awesome people there. About a month later, I decided to come to the weekly meetings. I really enjoyed it and began to learn about and understand the Bible and knowing who God is, but I didn't care for worship. I loved to ask questions, and my hope was that I could have every question answered and find contentment in that before committing to Jesus. But at Life Impact this past January, I was really moved by the worship that took place. And then my director told me that asking questions is great for understanding, however I wouldn't be able to have faith if I based it on whether or not my questions were answered to my satisfactory level. The last night of Life Impact was the night I accepted Christ. At the last big session, we started with worship and as I was singing the lyrics of Living Hope, I began to feel this giant wave of pain. I felt the pain of Jesus' sacrifice, I felt what it had meant for him to be crucified, I felt the pain of all my sins and the overall weight of knowing who Jesus is. I sat there for about two hours through the rest of the session crying, praying, and surrendering to Jesus. Up until this moment, I had known who Jesus is, and of his sacrifice, but I hadn't yet understood what it truly meant until I had felt it. Surrender had always been a scary word for me, I thought that by doing it I would be losing something, but I could not have been more wrong. I had been so used to having a wall up because I feared the feeling of hopelessness and being lost. Surrendering to God is one of the best things there is! I still do struggle with it however; this is why I continuously focus on giving all of myself to God. This reminds me a Bible verse I recently found, and it really struck home for me. Romans 12:2 says, "Do not be conformed to this world, but be transformed by the renewal of your mind, that by testing you may discern what is the will of God, what is good and acceptable, and perfect."

President's Report

Mark Spence

Mark Spence gave an update on the Annual Meeting Planning Committee. This year's annual Meeting will be held at Revive Church in Arvada on October 9-10. The theme this year is Partners in the Gospel, based on Philippians 1:3-6



Ministry Reports

Various ministry reports were given. These reports were given by Bill Lighty (PPBA), John Howeth (LPBA), Nate Templin (RGBA and AVBA), Jeff Bachman (GVBA and HCBA), Mike McVey (CDBA) and David Smith (UBA and MVBA).

Sexual Abuse Task Force Presentation Greg Teel

Greg Teel gave a report in which he stated that the Sexual Abuse Task Force was moving ahead in its plans to create a template for pastors and church leaders to use to screen volunteers. This form would also be used for trainings and be given to the Regional Directors as well. The task force also proposed from the Board of Directors a change in policy related to removal of individuals from convention positions. After much discussion about changes that needed to be made, the Executive Board voted to discuss the policy again at the May meeting and approve, with the conditions that the necessary changes were made.

Update on Strategies and Operations Rick Ackerman

PONDEROSA

Rick presented two items of business to the board for consideration.

ITEM 1:

Rick proposed updating our Ponderosa Management Committee (PMC) Policy to reflect our current needs and staff changes at the CBGC. Rick presented a document that included three changes:

- 1) Change the reporting relationship listed as "Associate Executive Director, CFO" to "Director of Convention Strategies" due to the fact that the CBGC no longer has an "Associate Executive Director, CFO" position.
- 2) Reduce the size of the PMC from 13 members to 9 members to have a more efficient team.
- 3) Remove the ability for the PMC to acquire debt up to 50,000 annually without bringing the request to the Executive Board for approval.

This item was presented in a document noting changes. A motion was made to approve these changes to the PMC Policy and was approved unanimously by the Executive Board.

ITFM 2

Rick requested the Executive Board consider nominating their member of the PMC at this meeting. The board requested volunteers to serve on the PMC. Rolland Kenneson offered to serve in this role if no one else desired to do so. The discussion was tabled until the Executive Board meeting reconvenes on Tuesday, January 17, 2023. On Tuesday, January 17, 2023, Danny Wolfe volunteered to serve on the PMC. A motion was made to nominate Danny. A second was made and the Executive Board unanimously approved Danny Wolfe to serve as their delegate on the PMC.

NEXT STEPS

Rick communicated to the board that the CBGC office has shifted the NEXT Step Strategy to the field through our Regional Directors as opposed to a centralized approach out of the CBGC office. This makes the ministry more accessible and effective for our churches. Rick communicated that we are currently working with our Regional Directors to develop a reasonable tracking system for churches in our NEXT Step Process.

Devotion and Prayer

Mark Spence

Mark Spence opened the meeting with a devotion and a time of prayer.

Ministry Reports

Various ministry reports were given. These reports were given by Dave Howeth (Send Denver), Steve Veteto (Gateway – RMC) and Dennis Belz (CBDR).

CBGC Financial Report Doug Lohrey

Doug presented the November 2022 Colorado Baptist Financial Report. He highlighted several issues in each of the financial reports. These reports were approved by the members of the Board.

Doug presented the Cooperative Program receipts for the year 2022. It was noted that we missed the budget for 2022 by \$55,173.43.

The CMO Balance Sheet was passed out and the grants that were paid were reviewed and ratified by the Board of Directors.

Motion Approved

Doug passed out the 2023 Proposed Colorado Mission Offering Allocation. It was explained that we had removed Ponderosa from the allocation when we tried to sell the camp, but now that we still own the camp then we have a desire to place Ponderosa back into the allocation program. There were other smaller changes made to the allocation as well. The Board voted to approve these changes unanimously.

Motion Approved

Doug, brought to the Board the budget for 2023 with a couple of changes. These changes consisted of reducing the World Mission percentage by 5%, This means that the state will be sending the Executive Committee 30% instead of 35%. This was recommended for the purpose of increasing the Colorado Baptist budget line for regional directors. Doug believes that this will better facilitate the work within our churches. Discussion followed, but in the end the Board of Directors unanimously voted to approve this motion.

There was a deacon in the church who was on the Colorado Bureau of Investigation's Registered Sex Offender list. The church refused to remove him from his position. This was after three physical meetings and multiple phone calls. There was some discussion by the board.

A board member made a motion to approve the disfellowship of First Southern Baptist Church, Lamar from the CBGC. The motion was seconded by another board member. The vote was unanimous.

Motion Approved

After the vote, Mike reported that he would send a letter to the Credentials Committee of the SBC, Lifeway, and the church itself letting the three entities know of the board's decision.

New Business and Miscellaneous Business

There was no new business or miscellaneous business to discuss.

COLORADO BAPTIST GENERAL CONVENTION CONSTITUTION AND BY-LAWS

CONSTITUTION

ARTICLE I -- NAME

This body shall be called the Colorado Baptist General Convention (cooperating with the Southern Baptist Convention).

ARTICLE II--PURPOSE

Section 1. This Convention is a non-profit corporation and is a cooperative body whose purpose is to provide a means by which cooperating churches encourage and assist one another in fulfilling the Great Commission. Section 2. This Convention has no authority over the cooperating churches, and shall in no manner endeavor to exercise control over the cooperating churches.

ARTICLE III--MEMBERSHIP

Section 1. This Convention shall be composed of messengers elected by the credentialed churches of the Colorado Baptist General Convention. A credentialed church is one that: 1) Has adopted and adheres to the Baptist Faith and Message 2000; 2) Is willing to partner together in the mission of this Convention and the Southern Baptist Convention through Cooperative Program giving; and 3) Is willing to actively participate in the ministries and events of this Convention.

Section 2. Each credentialed church is entitled to two (2) messengers if the membership is fifty (50) or less; plus one (1) additional messenger for each additional fifty (50) members or major fraction thereof. No church shall have more than ten (10) messengers.

ARTICLE IV--OFFICERS

Section 1. The officers of this Convention shall be president, first vice-president, second vice-president, recording secretary, and the executive director.

Section 2. These officers, with the exception of the executive director, shall be elected annually by this Convention and duly installed at the closing meeting of the Convention. They shall hold office until their successors are elected and installed. The executive director shall be elected by this Convention (in session) and shall serve for an indefinite term.

ARTICLE V--EXECUTIVE BOARD

- Section 1. This Convention shall elect an Executive Board as set forth in BY-LAWS IV.
- Section 2. This Convention has authorized the Executive Board to be this Convention in interim and the legal agent of this Convention for the purpose of transacting all business of this Convention, including approving churches to be credentialed, between annual meetings of this Convention. No person or spouse of a person serving on the Committee on Committees shall be nominated by the Committee on Committees.
- Section 3. The Executive Board shall employ all full-time Convention employees, except the executive director and ministry assistants, as is necessary for achieving the purpose of this Convention.
- Section 4. The chairman and/or vice chairman of the Executive Board and the executive director or chief financial officer of this Convention, as authorized, shall sign all legal papers of this Convention.
- Section 5. The Executive Board shall recommend to the messengers at the annual state convention a comprehensive operating budget setting forth anticipated receipts and disbursements. All designated funds shall be distributed as designated.
- Section 6. The Executive Board is authorized by this Convention to alter, as needed, Cooperative Program expenditures approved by the messengers at the state convention, but shall report the reasons for such needed changes to the messengers at the next annual meeting of this Convention.

Section 7. The Executive Board of this Convention should be composed of both ministers and laity of credentialed churches.

Section 8. Members of the Executive Board shall be recommended to the messengers by the nominating committee of this Convention and elected by the messengers to serve a three-year term. A member is eligible to serve a second three-year term if elected by the messengers. A person may be elected to an unexpired term, but no member may serve more than six (6) consecutive years until one full term (3 years) has elapsed. A person may not serve as a board member on the Executive Board and another agency or institution of this Convention at the same time. A person who is completing his service on the Executive Board may not be elected to another agency or institution until at least one full year has elapsed. A person who is completing service on an institution or agency of this Convention may not be elected to the Executive Board until one full year has elapsed.

Section 9. Should a vacancy occur on the Executive Board, the nominating committee of this Convention shall recommend a person to the Executive Board to fill the vacancy until the next regular meeting of this Convention. Section 10. The Executive Board shall present to the messengers at the annual state convention a written report both of their pertinent actions between meetings and recommendations which they deem advisable for

ARTICLE VI--AGENCIES, CORPORATIONS, INSTITUTIONS

Section 1. This Convention may create other agencies, corporations, and institutions as is necessary to carry out the purpose of this Convention. All Convention agencies, corporations, and institutions shall make annual written reports of their work to the messengers at the annual meeting of the state convention.

Section 2. The method of electing board members, committee members, and directors to serve on agencies, corporations and institutions, number of directors, their term of service, qualifications, responsibility and accountability are set forth in the by-laws of each respective agency, corporation and institution.

Section 3. The by-laws of each agency, corporation and institution of this Convention shall be adopted by its Board of Directors or committee. No by-laws shall be in conflict with the Constitution of this Convention.

Section 4. The agencies, corporations and institutions wholly owned by this Convention shall be managed in accordance with their respective articles of incorporation approved by the messengers of this Convention and filed on record with the Colorado Secretary of State.

ARTICLE VII--COMMITTEES

This Convention shall have the following standing committees: committee on committees, annual meeting planning, nominating, constitution, credentials, and such other committees as this Convention may deem necessary to carry out the work of this Convention.

ARTICLE VIII--MEETINGS

Section 1. This Convention shall meet annually at the time and place as determined by this Convention. Section 2. In an emergency, the president, in concurrence with this Convention's officers, and the Executive Board, may call a special meeting of this Convention and change the time and/or place of the regular annual convention.

ARTICLE IX AMENDMENTS

Section 1. This Constitution may be amended in the following manner:

- (1) Presenting copies of the proposed amendments to the messengers while this Convention is in session.
- (2) The proposed amendment is referred to the Constitution Committee for review. (See Article VII of the Constitution regarding standing committees and Article V, Section 6 of the By-laws regarding duties of the Constitution Committee)
- (3) Proposed amendment shall lie over until the next annual meeting of the Convention.
- (4) Proposed amendment shall require two-thirds majority vote of the messengers present and voting. Section 2. Except that Article II, Section 2, the purpose of this Convention reading, "This Convention has no authority over the cooperating churches, and shall in no manner endeavor to exercise control over the cooperating churches," shall not be amended.

COLORADO BAPTIST GENERAL CONVENTION BY-LAWS

I. TERRITORY

The Colorado Baptist General Convention shall be composed of messengers from credentialed churches in the State of Colorado.

II. MEMBERSHIP

Section 1. A church requesting credentialing with this Convention shall have adopted the <u>Baptist Faith and Message</u>, adopted by the Southern Baptist Convention at Orlando, Florida in June, 2000.

Section 2. This Convention Credentials Committee shall carefully examine each church requesting credentialing with this Convention and, if satisfied, recommend the credentialed churches to the Executive Board of this Convention or Convention Body of churches at the seating of their messengers at the annual meeting of the state convention.

Section 3. For churches desiring credentialing, the church must submit all necessary information to the Credentials Committee no later than 60 days before the next Executive Board Meeting.

Section 4. A church desiring a continuing cooperation with this Convention must abide by Article III, Section I, of the Constitution.

Section 5. A church seeking credentialing with this Convention is encouraged to be in a cooperative fellowship with the Southern Baptist association in which the church is geographically located.

III. OFFICERS

Section 1. The executive director of this Convention shall be elected for an indefinite time by the messengers of the State Convention at a regular or called meeting of this Convention.

Section 2. Other officers shall be nominated from the floor and elected by ballot. Election may be by acclamation of the body, or the vote cast by the recording secretary, if there is only one nominee.

Section 3. The President shall not be an employee of the Executive Board.

Section 4. The President, at his discretion, may appoint a parliamentarian.

Section 5. The President and the officers are eligible to serve only two terms in succession, with the exception of the recording secretary.

Section 6. In the event of vacancies, the succession to officers shall be as follows: 1st vice-president, 2nd vice-president. If the three offices are vacant, the Executive Board shall appoint a moderator to preside at the annual meeting.

IV. EXECUTIVE BOARD

Section 1. Both ministers and laity who serve on the Executive Board shall be recommended to the messengers by this Convention's Nominating Committee. A minister is defined herein as an ordained person who is serving a church credentialed with this Convention.

Section 2. Board members are elected by this Convention from geographical areas, called associations, to represent the total interests and programs of this Convention and not as representatives of the association.

Section 3. The basis for electing both ministers and laity to serve on the Executive Board from ASSOCIATIONAL areas throughout the state shall be as follows:

- (1) An association must have been organized and operating for at least sixty days prior to the annual meeting of this Convention.
- (2) One (1) Board member from each associational area that has a minimum of five (5) credentialed churches and at least four hundred (400) members.
- (3) Three (3) at-large members.

Section 4. Officers of the Board shall be the chairman, vice-chairman, second vice-chairman, and the executive director

- Section 5. The officers of this Convention shall serve the Executive Board as follows:
 - (1) The president of this Convention shall serve as the chairman of the Board.
 - (2) The first vice-president of this Convention shall serve as first vice-chairman of the Board.

- (3) The second vice-president of this Convention shall serve as second vice-chairman of the Board.
- (4) The recording secretary shall be an ex-officio member of the Executive Board.
- Section 6. Qualifications to serve, or continue to serve, on the Executive Board shall be as follows:
 - (1) Be a resident of Colorado for at least one year.
 - (2) Be a member of a credentialed church that regularly contributes to missions through the Cooperative Program.
 - (3) Be supportive of and compatible with the vision and goals of this Convention.
 - (4) Be someone other than an employee of the Executive Board.
 - (5) Be retired from the Board immediately when moving from the associational area where living when elected, with exception of the at-large members.
 - (6) Attendance at all scheduled and called Executive Board meetings is mandatory except when there is justifiable cause. Notification of absence should be given prior to the Executive Board meeting. Failure to comply with these attendance requirements will result in retirement from the Executive Board.
- Section 7. Two-thirds of the Executive Board members shall constitute a quorum at any Board meeting.
- Section 8. The Board shall organize itself as is necessary to carry out Board responsibilities.
- Section 9. The Board shall prescribe the preferred ends to be achieved by Convention staff.

V. COMMITTEES

- Section 1. The Annual Meeting Planning Committee shall consist of this Convention's officers, with the president serving as chairman, the executive director, and the host pastor. This committee shall be responsible for planning all aspects of the annual meeting of this Convention.
- Section 2. The Committee on Committees, composed of five (5) members, shall be appointed by the president of the Convention by the Executive Board meeting following the annual Convention. This committee shall nominate for election by Convention the Nominating Committee, Resolutions Committee, Credentials Committee, Constitution Committee, and all special committees authorized during the meeting of this Convention. This committee shall be responsible for properly informing the various committees of their responsibilities. No person or spouse of a person serving on the Committee on Committees shall be nominated by the Committee on Committees.
- Section 3. The Nominating Committee shall be a standing committee composed of nine (9) members with three (3) members rotating off each year. This committee shall recommend to the messengers at the annual meeting persons for election to serve on the Executive Board, agencies, corporations and institutions in accordance with their respective by-laws. No person or spouse of a person serving on the Nominating Committee shall be nominated by the Nominating Committee.
- Section 4. The Resolutions Committee shall be a standing committee composed of six (6) members with two (2) members rotating off each year. This committee shall formulate resolutions they deem appropriate and report them to this Convention.
- Section 5. The Credentials Committee shall be a standing committee composed of six (6) members with two (2) members rotating off each year. It shall study the request of each church seeking credentialing with this Convention and recommend Convention action relative to seating of messengers. The committee is encouraged to contact Convention churches which do not currently appear to be in cooperation, in order to restore their cooperation. (See Constitution, Article III, Section 1). When necessary, this committee may be authorized to examine messengers from any of the credentialed churches whose seats are contested and recommend Convention action.
- Section 6. The Constitution Committee shall be a standing committee composed of six (6) members, with two (2) members rotating off each year. This committee shall receive and study proposed amendments to the Constitution and By-laws, and shall formulate whatever amendments it may consider proper and report them to this Convention in the manner prescribed in the Constitution and By-laws. Messengers may present proposed amendments to this Convention according to Article VII for referral to this committee.

VI. CONVENTION EMPLOYEES

Section 1. The Executive Board shall employ all Convention personnel except the executive director and ministry assistants, as is required to do the work of this Convention, upon recommendation of the executive director.

- Section 2. The Executive Board shall employ all full-time salaried personnel on an indefinite basis. A thirty-day notice shall be given by either party of the desire to end the contract, except by mutual agreement.
- Section 3. The executive director shall employ all ministry assistants in counsel with department directors.
- Section 4. Convention staff shall organize themselves to achieve the ends set forth by the Executive Board.
- Section 5. The executive director shall give general supervision and counsel to the work of this Convention through its departments and agencies, and will present a written report of his stewardship to this Convention at the annual meeting.
- Section 6. The executive director shall be accountable to the Executive Board for achieving the ends set forth by the Board.
- Section 7. The executive director is the chief executive officer for the Executive Board; the professional advisor for the Executive Board and Board committees; and must endeavor to be one of the denomination's chief spiritual leaders in providing state-wide guidance and inspiration.
- Section 8. The executive director shall serve ex-officio, without voting, on all committees and aid by furnishing information, printed materials and needed guidance for the work of the committees.
- Section 9. When the office of the executive director is vacant, the Executive Board shall elect a special search committee to find a qualified man to recommend to the messengers at the next regular or called meeting of this Convention to fill the vacancy.
- Section 10. Should the office of the executive director become vacant between meetings of this Convention, the Executive Board shall name an interim executive director until the executive director is duly elected.

VII. AMENDMENTS

These By-laws may be amended in the following manner:

- 1. An amendment must be presented in writing and copies made available to the messengers during the first session of the annual convention.
- 2. The proposed amendment is referred to the Constitution Committee for review. (See Article V, Section 6 of the By-laws)
- 3. An amendment may be voted on at a stated time during a subsequent session of the annual convention.
- 4. The proposed amendment must receive a two-thirds majority of those voting.

VIII. RULES OF ORDER

The New Testament and "The Standard Code of Parliamentary Procedure" new and revised by the American Institute of Parliamentarians shall govern the deliberations of messengers during the meetings of this Convention.
